## **THE SAMOYED BREED JUDGING CRITERIA**

### **A1 List**

For persons who have previously been approved by the Kennel Club to award CC's in the breed and have completed their first appointment and have the support of a Samoyed Breed Council/Club/Society. ( KC Policy ).

### **A2 List**

For persons who fulfil all the requirements for the A3 list and who have been assessed in accordance with KC requirements and accepted by the KC for inclusion on an A2 list and have the support of a Samoyed Breed Council/Club/Society. ( KC Policy ).

### **A3 List**

#### **Breed Specialists**

Requirements Include:-

1. A minimum of seven (7) years judging experience in the breed and have the support of a Samoyed Breed Council/Club/Society. (KC Policy).
2. To have judged at a Breed Club Show or three (3) Breed Club Supported Entry Shows.
3. To have judged a minimum of forty (40) Samoyed Classes.
4. To have judged a minimum of one hundred (100) Samoyeds. (KC policy Number optional by Club).
5. To have attended a seminar given by a kennel Club Accredited Trainer and passed the relevant examination on Kennel Club Regulations and Judging Procedures. (KC policy as of 01/07/2001).
6. To have attended a seminar given by a kennel Club Accredited Trainer on Conformation and Movement. (KC Policy as of 01/07/2001).
7. To have attended a 'Points of the Dog Assessment' conducted by a Kennel Club Accredited Trainer and passed the assessment. (KC Policy as of 01/07/2005).
8. To have attended at least one (1) Breed specific seminar run in accordance with the relevant Kennel Club code of best practice and passed an examination and /or assessment where applicable. (KC Policy as of 01/07/2001).
9. To have bred and /or owned a minimum of three (3) dogs when they obtained their first entry in the in the Kennel Club Stud Book (Save in exceptional circumstances). (KC Policy).
10. To have Stewarded at 12 shows. (KC Policy).

### **A3 List**

## **Non Specialists**

Requirements Include:-

1. A minimum of seven (7) years judging experience in any one breed (To include five (5) years experience in the Samoyed breed) and have the support of a Samoyed Club/Society. (KC Policy).
2. To have judged at a Breed Club Show or three (3) Breed Club Supported Entry Shows.
3. To have judged a minimum of fifty (50) Samoyed Classes.
4. To have judged a minimum of one hundred and twenty (120) Samoyeds. (KC policy Number optional by Club).
5. To have awarded CC's in at least one other breed. (KC Policy).
6. To have attended at least one (1) Breed specific seminar run in accordance with the relevant Kennel Club code of best practice and passed an examination and /or assessment. (KC Policy as of 01/07/2001).
7. To have bred and/or owned a minimum of three (3) dogs of any breed when they obtained their first entry in the in the Kennel Club Stud Book (Save in exceptional circumstances). (KC Policy).

## **B List**

### **Breed Specialists:-**

1. To have five (5) years experience owning and exhibiting Samoyeds and have the support of a Samoyed Breed Club/Society.
2. To have judged six (6) Classes of Samoyeds at Open Shows or Championship Shows without CC's.
3. To have judged twelve (12) Samoyeds.

## **B List**

### **Non Specialists:-**

1. To have five (5) years experience in any one (1) breed and have the support of a Samoyed Breed Club/Society.
2. To have judged nine (9) Classes of Samoyeds at Open Shows or Championship Shows without CC's.
3. To have judged twenty (20) Samoyeds. (Save in exceptional circumstances)

## **C List**

### **Breed Specialists and Non Specialists:-**

For aspirant judges who have shown an interest in Samoyeds and have the support of a Samoyed Breed Club/Society.

(Listings would normally include persons who have judged the breed at Limited or Open Shows but do not yet qualify for the B lists)
